

# UNIVERSAL EXCLUSIONS FOR SPARINVEST FUNDS

ESG integration and stewardship are at the heart of Sparinvest's approach to responsible investment. We believe that these powerful tools enable investors to maintain diversified portfolios while addressing ESG issues. In our active funds, this is one of the factors that can lead our teams to select or reject potential investments. Across our funds, we also work with companies to encourage stronger governance and sustainability.

However, we set a clear baseline: No Sparinvest fund – whether actively or passively managed - invests in companies with confirmed involvement in production or distribution of controversial weapons. This means: anti-personnel mines, cluster munitions, biological weapons, chemical weapons, depleted uranium and nuclear weapons outside the Nuclear Non-Proliferation Treaty.

Moreover, the universal exclusions also include companies such as extreme climate transition laggards and companies, who have been unwilling to solve or mitigate confirmed breaches of international norms.

Our decisions on whether to exclude companies from the investment universe are based on information from an independent external consultancy, which monitors the universe continuously and screens both listed and unlisted companies.
