The board of directors of the Company wishes to inform you that the Company's current prospectus (the "Prospectus") has been updated with respect to the following:

1. CHANGE AT THE LEVEL OF EXTERNAL INVESTMENT MANAGER

The Company's sub-investment manager (Nykredit Bank A/S) has decided to stop the cooperation with external investment manager (Harding Loevner LP). The pool name changes from Sparinvest SICAV - Global Equity Growth Pool (Harding Loevner) to Sparinvest SICAV - Global Equity Growth Pool accordingly.

2. CHANGE AT THE LEVEL OF POOLS

The pool Sparinvest SICAV - Global Equity Growth Index Pool changes its name to Sparinvest SICAV - Global Equity Allocation Pool, as the strategy has transitioned from an exclusive focus on Global Equity Growth to a dynamic allocation across various segments of the global equity markets. This change is intended to enhance the risk-return profile of the sub-funds invested in the pool. The above-mentioned change does not impact the fees charged to the relevant sub-funds as well as the risk profiles of the sub-funds. The impact of the relevant sub-funds' portfolio is marginal.

3. OPENING A NEW POOL

A new pool Sparinvest SICAV - Global Equity Select Pool will be opened to provide the Company's sub-investment manager (Nykredit Bank A/S) with more options and flexibility in constructing efficient portfolios. The above-mentioned change does not impact the fees charged to the relevant sub-funds as well as the risk profiles of the sub-funds. The impact of the relevant sub-funds' portfolio is up to 10%.

4. CHANGE OF NOMINEE FOR SHAREHOLDERS IN DENMARK

With effect from 1 November 2025, Jyske Bank A/S was replaced by Nykredit Bank A/S for performing the function of nominee for shareholders in Denmark. The section 21. "Nominee for Shareholders in Denmark" and section 27. "Documents" is updated accordingly.
